NCCC/West Region Meetings September 13-14, 2024 St. Louis, MO

The 2025 NCCC National Convention will be held in the Wisconsin Dells August 17-22, 2025. Current information is available on the NCCC website under the Convention tab. The 2024 NCCC convention, held in Joplin, MO this year reported that the convention made approximately \$36,000.00.

The RCDs are working on the following matters:

Teardown requirements for C8s as they relate to the record drag program. The RCDs are looking at alternatives to this requirement.

Parade laps may become required for all low and high speed autocross events. If approved, this will be included in the 2026 rulebook.

Training for course workers and drivers on the use of fire extinguishers may become mandatory. More to come on this.

A Safety Committee is being formed to develop guidelines for required training for event workers.

NCCC FCOA program currently has 1,085 members. That number is down 11% from last year. NCCC membership stands at 18,686 with 235 clubs.

The NCCC membership database will be shut down October 1-2, 2025. Following the shutdown, it will reopen, and membership renewals will be accepted. When submitting membership renewals, it has been requested the members list their newest Corvette owned in the member information. This will allow NCCC to provide potential sponsors with an approximate count of C7 and C8 models owned by the membership. Additional owned Corvettes should be reported in the comments section of the membership database. Club governors and/or membership directors are responsible for updating this information. All membership renewal processing MUST be completed by November 15, 2024.
